Vendor should call Market Manager by Thursday night, on a weekly basis, and request space for Saturday, however, qualified vendors may be accepted the morning of the market day if space is available, and will be assigned to booth space as available by Market Manager or his/her assistant. Payment for space fee is due, in cash (or approved check), by 8:30 a.m., morning of the market, or as otherwise collected by the Market Manager.
